- ✓ **Adherence to laws and ordinances together with social standards**
- ✓ **Adherence to our Code of Conduct for suppliers and business partners**
- ✓ **Forbearance of attempted bribery and/or the procurement of advantages**
- ✓ **Experience in the automotive sector together with the implemented standards EMPB, IMDS, component inspections**
- ✓ **In some product groups a quality management system is required with valid certification in accordance with the standards ISO 9001 or IATF 16949 or VDA 6.1 or a comparable system; in the remaining product groups at least one documented quality management system is required**
- ✓ **An environmental management system with valid certification in accordance with the standard ISO 14001 or a comparable or higher-level standard is required in the context of sustainability**
- ✓ **Cooperation to address requirements and solve problems**
- ✓ **Acceptance of our terms and conditions of purchasing as well as of the standard delivery and payment conditions**
- ✓ **Stable financial situation together with the disclosure of required financial data for the audit trail**
- ✓ **Further development potential (continuous product and process development)**
- ✓ **High standard of technology**
- ✓ **Must safeguard processes by taking the appropriate precautions (risk management, insurance policies)**
- ✓ **Desire to establish a long-term partnership**
